

ABOUT THIS PROPERTY

Welcome to Weston's Case Estates and surrounding open space, where 3 miles of trails wind through 100 acres of forests, fields, and wetlands. The Weston Conservation Commission, Weston Select Board, and Weston Forest & Trail Association work together to care for this treasured land. Case Estates sits on the original homeland of the Massachusetts Tribal Nation. From 1909 until the early 2000's, much of this land was home to an experimental farm and horticultural center under the care of Marian Case (until 1944) and then Harvard's Arnold Arboretum. Look for remnants of this unique history on your visit, such as the stone incinerator and the 100-year old Rhododendron Garden. Two wide trails with firm surfaces and gentle grades cross the property: the Legacy Trail (0.3 miles), which ends at a scenic overlook; and a 0.4-mile path that travels from the Legacy Trail across Wellesley St. to Ash St. Both are shown in yellow on the map. Other trails connect to Chestnut St., Davenport Rd., Woodland School, and Linwood Cemetery.

DIRECTIONS & PARKING

The main trailhead is located on Alphabet Ln across from the lower Community Center entrance (20 Alphabet Ln). From School St, turn onto Alphabet Ln (one way); at the rotary, go 3/4 around. Park in the lot located between the Field School and the Community Center (or in the lot across Alphabet Ln). Follow the crosswalk from the Community Center across Alphabet Ln to the trailhead.

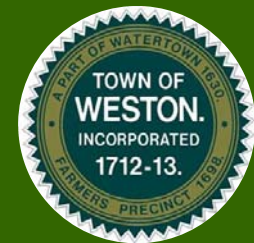
